AN ORDER DESIGNATING HON. MATT P. PALABRICA, Ph.D., AS OFFICER-IN-CHARGE (OIC) OF THE OFFICE OF THE MUNICIPAL MAYOR OF THE MUNICIPALITY OF BINGAWAN, ILOILO ON MARCH 14 UNTIL MARCH 16, 2018 WHILE THE MUNICIPAL MAYOR, HONORABLE MARK P. PALABRICA IS ON OFFICIAL TRAVEL TO METRO MANILA TO FOLLOW-UP HEAVY EQUIPMENT LOAN AND VARIOUS PROJECTS OF THE MUNICIPALITY OF BINGAWAN AT MUNICIPAL DEVELOPMENT FUND OFFICE (MDFO)/ BUREAU OF LOCAL GOVERNMENT FINANCE (BLGF) AND BANGKO SENTRAL NG PILIPINAS.

WHEREAS, Section 46 (c) of Republic Act 7160 otherwise known as the Local Government Code of 1991 states that " when the incumbent local chief executive is traveling within the country but outside his territorial jurisdiction for a period not exceeding three(3) consecutive days, he may designate in writing the officer-in-charge of the said office. Such authorization shall specify the powers and functions that the local official concerned shall exercise in the absence of the local chief executive except the power to appoint, suspend, or dismiss employees";


WHEREAS, the Municipal Mayor is on official travel to Metro Manila for three (3) days to follow-up heavy equipment loan and various projects of the municipality of Bingawan at Municipal Development Fund Office (MDFO)/ Bureau of Local Government Finance (BLGF) and Bangko Sentral ng Pilipinas;

NOW THEREFORE, I, MARK P. PALABRICA, Municipal Mayor of the Municipality of Bingawan, Province of Iloilo, by virtue of the powers vested in me by law, do hereby order, that;

- Section 1. Hon. Matt P. Palabrica, Ph.D. is hereby designated as Officer-In-Charge (OIC) of the Office of the Municipal Mayor of the Municipality of Bingawan, on March 14 until March 16, 2018 while the Municipal Mayor, Honorable Mark P. Palabrica is on official travel to Metro Manila to follow-up heavy equipment loan and various projects of the municipality of Bingawan at Municipal Development Fund Office (MDFO)/ Bureau of Local Government Finance (BLGF) and Bangko Sentral ng Pilipinas.
- Section 2. The OIC-Mayor shall automatically exercise the powers and perform the duties and functions of the local chief executive concerned, except the power to appoint, suspend, or dismiss employees.
- Section 3. This Executive Order shall take effect immediately on the date above stated.
