AN ORDER RECONSTITUTING THE HUMAN RESOURCE MERIT PROMOTION AND SELECTION BOARD OF THE MUNICIPALITY OF BINGAWAN, PROVINCE OF ILOILO.

WHEREAS, the Civil Service Commission adopted and promulgated the 2017 Omnibus Rules on Appointments and Other Human Resource Actions pursuant to CSC Resolution No. 1701009 dated June 16, 2017 and Memorandum Circular No. 24, s. 2017 dated August 24, 2017 to govern the preparation, submission of, and actions to be taken on appointments and other human resource movements;

WHEREAS, the Sangguniang Bayan of the Municipality of Bingawan, Iloilo passed Resolution No. 33-2018, establishing the Human Resource Merit Promotion and Selection Board (HRMPSB) in the Municipality of Bingawan, Province of Iloilo pursuant to Sections 84 and 88 of the 2017 Omnibus Rules on Appointments and Other Human Resource Actions;

WHEREAS, the Human Resource Merit Selection and Promotion Board (HRMPSB) shall serve as the recommending body for appointment in the agency;

NOW THEREFORE, I, MARK P. PALABRICA, Municipal Mayor of the Municipality of Bingawan, Iloilo, by virtue of the powers vested in me by law, do hereby reconstitute the Human Resource Merit Promotion and Selection Board of the Municipality of Bingawan, Iloilo, as follows:

C. Secretariat to the HRMPSB


