EXECUTIVE ORDER NO. 26

AN ORDER DESIGNATING HON. MATT P. PALABRICA, Ph.D., AS ACTING MUNICIPAL MAYOR OF THE MUNICIPALITY OF BINGAWAN, ILOILO ON SEPTEMBER 6 UNTIL SEPTEMBER 11, 2018 WHILE THE MUNICIPAL MAYOR, HONORABLE MARK P. PALABRICA IS ON OFFICIAL TRAVEL TO NANNING CITY, GUANG XI, CHINA TO ATTEND THE CHINA-ASEAN MAYOR'S FORUM.

WHEREAS, Section 46 (c) of Republic Act 7160 otherwise known as the Local Government Code of 1991 states that " when the incumbent local chief executive is traveling within the country but outside his territorial jurisdiction for a period not exceeding three(3) consecutive days, he may designate in writing the officer-in-charge of the said office. Such authorization shall specify the powers and functions that the local official concerned shall exercise in the absence of the local chief executive except the power to appoint, suspend, or dismiss employees";

WHEREAS, Section 46 (d) of Republic Act 7160 otherwise known as the Local Government Code of 1991 states that " in the event, however, that the local chief executive concerned fails or refuses to issue such authorization, the vice-governor, the city or municipal vice-mayor, or the highest ranking sangguniang bayan member, as the case may be, shall have the right to assume the powers, duties, and functions of the said office on the fourth (4th) day of absence of the said local chief executive subject to the limitations provided in subsection (c) hereof";

WHEREAS, the Municipal Mayor is on official travel on September 6 until September 11, 2018 to travel to Nanning City, Guang XI, China to Attend the China-Asean Mayor's Forum.

NOW THEREFORE, I, MARK P. PALABRICA, Municipal Mayor of the Municipality of Bingawan, Province of Iloilo, by virtue of the powers vested in me by law, do hereby order, that;


Section 1. Hon. Matt P. Palabrica, Ph.D. is hereby designated as Acting Municipal Mayor of the Municipality of Bingawan, Iloilo on September 6 until September 11, 2018 while the Municipal Mayor, Honorable Mark P. Palabrica is on official travel to Nanning City, Guang XI China to attend the China-Asean Mayor's Forum.

Section 2. The Acting Mayor shall automatically exercise the powers and perform the duties and functions of the local chief executive concerned, except the power to appoint, suspend, or dismiss employees.

Section 3. This Executive Order shall take effect on the above-stated date.
