AN ORDER REORGANIZING THE MEMBERSHIP OF THE PEOPLE'S LAW ENFORCEMENT BOARD (PLEB) OF THE MUNICIPALITY OF BINGAWAN, PROVINCE OF ILOILO.

WHEREAS, Section 43 (a) of R.A. 6975 as amended by R.A. 8551 reads " People's Law Enforcement Board (PLEB)-(a) Creation and Functions- The sangguniang panglungsod/ bayan in every city and municipality shall create such number of People's Law Enforcement Boards (PLEBs) as may be necessary;

WHEREAS, Section 66 of R.A. No. 8551 also known as "Philippine National Police Reform and Reorganization Act of 1998" states that "the PLEB shall be the central receiving entity for any citizen's complaint against the officers and members of the PNP. Subject to the provisions of Section 41 of Republic Act No. 6975, the PLEB shall take cognizance of or refer the complaint to the proper disciplinary or adjudicatory authority within three (3) days upon the filing of the complaint;

WHEREAS, the Sangguniang Bayan has chosen Hon. Leovy C. Simora to sit at the People's Law Enforcement Board;

WHEREAS, Hon. Roger Pamocol was recommended by the Liga ng mga Barangay to represent the Punong Barangays at the Board;

WHEREAS, Section 67 of the said Republic Act further states that "Three (3) other members who are removable only for cause to be chosen by the local peace and order council among the respected members of the community known for their probity and integrity, one (1) of whom must be a woman and another a member of the Bar, or, in the absence thereof, a college graduate or the principal of the central elementary school in the locality;

WHEREAS, the Municipal Peace and Order Council recommended three individuals to sit as representative to the People's Law Enforcement Board (PLEB) namely Kagawad Lerry Celestial, representing the women's sector; Mr. Elmer Pamocol, a college graduate and Mr. Gervacio Genturo, Jr., Principal II of the Bingawan Central Elementary School;


WHEREAS, the People's Law Enforcement Board (PLEB) shall be the central receiving entity for any citizen's complaint against the officers and members of the PNP and shall have jurisdiction to hear and decide cases filed before it.

WHEREAS, Ms. REZEL MONTILLA is designated as Secretariat of the Board pursuant to Section 3.4.1 of DILG MC No. 2017-154 "Operational Guidelines on the Implementation of the People's Law Enforcement Board (PLEB) Program" which provides for the designation of a PLEB Secretariat;

NOW, THEREFORE, I, MARK P. PALABRICA, Municipal Mayor of the Municipality of Bingawan, Province of Iloilo, by virtue of the powers vested in me by law, do hereby provide for the membership of the People's Law Enforcement Board (PLEB) of the Municipality of Bingawan, Province of Iloilo.

Effectivity. This order shall take effect immediately.
