**MUNICIPAL ORDINANCE NO. 236
(Series of 2017)**

AN ORDINANCE DECLARING THE LAST FRIDAY OF JULY OF EVERY YEAR AS THE MUNICIPAL LIGA DAY IN THE MUNICIPALITY OF BINGAWAN, PROVINCE OF ILOILO

[Principal Sponsor: HON. PERCEVAL T. GIRAO AND HON. LEOVY C. SIMORA]

[Co-Sponsor - Committee on Barangay Affairs]

Be it ordained by the Sangguniang Bayan of Bingawan, Iloilo that:

Section 1. TITLE - This ordinance shall be known and cited as the "Municipal Liga Day Ordinance of 2017".

Section 2. DECLARATION OF POLICY - It is hereby a declared policy of the Local Government of Bingawan to promote camaraderie to its Barangay Officials both elective and appointive as the frontliners of delivering basic services especially in Barangay levels. Further, it also aimed to showcase their best practices, talents and skills and thereby encourages the participation of every Barangays in conducting the same pursuant to Article 3, Section 8 of the Philippine Constitution of 1987 that provides "The right of the people, including those employed in the public and private sectors, to form unions, associations, or societies for purposes not contrary to law shall not be abridged."

Section 3. FUNDING - To effectively implement this ordinance each Barangay shall appropriate funds every ensuing year to be included in their Annual Budget subject to budgeting laws, rules and regulations.

Section 4. DATE AND VENUE - The Liga ng mga Barangay Day shall be held every last Friday of July of every year at the Municipal Gymnasium.

Section 5. ADMINISTRATIVE PROVISION - The Liga ng mga Barangay thru the leadership of its Liga President shall create a committee to ensure and oversee the smooth flow of their activities and programs that may be identified by the league.


Section 6. REPEALING CLAUSE - If any provision of this ordinance is declared invalid or inconsistent with existing laws, rules, and issuances, the said provision is hereby modified and repealed accordingly.

Section 7. EFFECTIVITY - This ordinance shall take effect fifteen (15) days after its approval.


