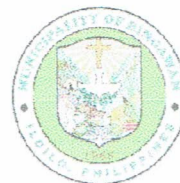

**MUNICIPAL ORDINANCE NO. 239
(Series of 2017)**

AN ORDINANCE ESTABLISHING THE VICTOR CATEDRAL PLAGATA CUP IN THE MUNICIPALITY OF BINGAWAN, PROVINCE OF ILOILO AND PROVIDING FUNDS THEREOF.

WHEREAS, Section 19, Article XIV of the Philippine Constitution provides that “the state shall promote physical education and encourage sports programs, league competitions, and amateur sports, XXX to foster self discipline, teamwork and excellence for the development of a healthy and alert citizenry”;

WHEREAS, the late Victor Catedral Plagata was the founding Mayor of the Municipality of Bingawan, Iloilo and was a sports enthusiast who promoted sports especially volleyball in the Municipality of Bingawan during his term;

WHEREAS, the Victor Catedral Plagata Cup is conducted every second week of May for ten (10) years and spearheaded by the Plagata family;

WHEREAS, the Victor Catedral Plagata Cup, is dubbed to be one of the exciting tourism sports attractions in Central Panay and is well participated by various teams from all over the region and other parts of the country;

WHEREAS, volleyball is considered a popular sport and in fact declared as the official sport in Bingawan as per Resolution No. 10-2017, and many international, national and regional volleyball athletes are being produced by Bingawan;

WHEREAS, the tournament has been proven to be a good vehicle to foster and promote goodwill, friendship, sportsmanship, camaraderie and brotherhood among the people of Bingawan and as well as the different participating teams from various provinces and organizations;

NOW THEREFORE:

ON MOTION of Hon. Leovy C. Simora, duly seconded by Hon. Perceval T. Girao;

Be it ordained by the Sangguniang Bayan of the Municipality of Bingawan, Province of Iloilo, in a Regular Session assembled, that:

Section 1. Scope. The Victor Catedral Plagata Cup shall focus mainly but not limited to volleyball and shall be held every 2nd week of May of every year.

Section 2. Organization, Management and Administrative Provision. There is hereby created the Victor Catedral Plagata Cup Council that shall serve as the highest policy making and governing body and shall be composed of the following:

The appointment of the foregoing shall be supported by an Executive Order of the Municipal Mayor and a resolution of the Sangguniang Bayan. The Office of the Mayor shall issue such other rules and regulations in implementing this ordinance.

Section 3. Funding. A certain amount shall be appropriated for the holding of the Victor Catedral Plagata Cup and shall be taken from the Office of the Mayor, subject to all legal and auditing rules and procedures.

The local government unit can accept cash and in kind from the families and friends of Victor Catedral Plagata, private organizations, government agencies and institutions to further enhance the conduct of the Cup.

Section 4. REPEALING CLAUSE. This Ordinance repeals, modifies or amends any existing Ordinance inconsistent herewith, other provisions not affected shall remain in full force and effect.

Section 5. Effectivity. This ordinance shall take effect immediately upon its approval.




