**AN URGENT ORDINANCE AUTHORIZING HON. MATT P. PALABRICA, Ph.D. MUNICIPAL VICE MAYOR, TO AUGMENT THE AMOUNT OF NINETY NINE THOUSAND, FIVE HUNDRED ELEVEN PESOS AND 08/100 (P99,511.08) AS SAVINGS FROM PERSONNEL SERVICES/SALARIES AND WAGES-REGULAR PAY OF SANGGUNIANG BAYAN MEMBER/SK PRESIDENT TO MONETIZATION OF LEAVE CREDITS.**

**WHEREAS**, Section 336 of RA 7160, otherwise known as the “Local Government Code of 1991”, provides that “the local chief executive or the presiding officer of the sanggunian concerned may, by ordinance, be authorized to augment any item in the approved annual budget for their respective offices from savings in other items within the same class of their respective appropriations”;

**WHEREAS**, Mrs. Lorna Pedroso, requested for a monetization of her leave credits in the amount of One Hundred Pesos (P100,000.00) to defray her hospital bills due to pneumonia;
