**Resolution No. 02 – 2017**

**URGENT RESOLUTION AUTHORIZING HON. MARK P. PALABRICA, MUNICIPAL MAYOR, MUNICIPALITY OF BINGAWAN, ILOILO TO ENTER AND SIGN FOR AND IN BEHALF OF THE MUNICIPALITY OF BINGAWAN, ILOILO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF HEALTH REGIONAL OFFICE (DOH-RO)-WESTERN VISAYAS WITH PRINCIPAL ADDRESS AT MANDURRIA, ILOILO CITY AND HEREIN REPRESENTED BY ITS REGIONAL DIRECTOR IV, DR. MARLYN W. CONVOCAR FOR THE INTEGRATED CLINIC INFORMATION SYSTEM (iClinicSys)**

**WHEREAS**, the DOH being a national agency ensures the protection of health of every Filipino, provides assistance to health partners and stakeholders on the use of Information and Communication Technology (ICT) in health care to improve service delivery and access to health information;

**WHEREAS**, Republic Act 7160 otherwise known as the 1991 Local Government Code mandated the devolution of the delivery of health services and facilities as one of the basic functions and responsibilities of all LGU's at all levels;

**WHEREAS**, the Epidemiology Bureau (EB), Disease Prevention and Control Bureau (DPCB) and Knowledge Management and Information Technology Service (KMITS) of the DOH have developed the Integrated Clinic Information System (iClinicSys) for implementation of healthcare facilities as a tool for patient management and reporting field health services data and other DOH reporting requirements;

**WHEREAS**, the LGU desires to use the DOH iClinicSys as an electronic medical record and health information system which will be use for the health services to manage the patient demographics, medical histories, diagnoses, treatments, medications, laboratory requests and results and generate the required data for their use and also submission to DOH;

**WHEREAS**, the LGU agrees to comply with all required or applicable Philippine governing laws, policies, ordinances, memoranda and other issuances or mandate related to the iClinicSys.

**WHEREAS**, Section 22 (c) of RA 7160 provides that “no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the Sanggunian concerned”.

**NOW THEREFORE:**

**RESOLVED AS IT IS HEREBY RESOLVED**, to authorize Hon. Mark P. Palabrica, Municipal Mayor, Municipality of Bingawan, Iloilo to enter and sign for and in behalf of the Municipality of Bingawan, Iloilo a Memorandum of Agreement with the Department of Health Regional Office (DOH-RO)-Western Visayas with principal address at Mandurriao, Iloilo City and herein represented by its Regional Director IV, Dr. Marlyn W. Convocar for the Integrated Clinic Information System (iClinicSys).


