AN URGENT RESOLUTION ADOPTING THE PUBLIC FINANCIAL MANAGEMENT IMPROVEMENT PLAN (PFMIP) 2016- 2019 OF THE MUNICIPALITY OF BINGAWAN, ILOILO.

WHEREAS, the Municipality of Bingawan is a recipient of formerly Bottom up Budgeting (BuB), now, Assistance to Disadvantaged Municipalities (ADM) for FY 2017 project under the Local Government Support Fund (LGSF);

WHEREAS, the Public Financial Management Improvement Plan was prepared by the Public Financial Management Assessment Team created through Executive Order No. 18, s. 2016;

WHEREAS, similar to the BuB, the Assistance to Disadvantaged Municipalities (ADM) imposes a governance requirement wherein the municipal governments have to meet good governance standards in order to avail of the said financial assistance;

WHEREAS, the Seal of Good Financial Housekeeping (SGFH) compliance and the Public Financial Management Improvement Plan (PFMIP) measures are the conditioning requirements for the release of the LGU share from the LGSF;

WHEREAS, Sangguniang Bayan Resolution Adopting the Public Financial Management Improvement Plan is hereby required in order for the Department of budget and management to issue a certification that the LGU has complied with the requirements.


