WHEREAS, the Taytay sa Kauswagan, Incorporated (TKSI) only signified their intent to participate on the said accreditation last January 20, 2017;

WHEREAS, after a thorough evaluation of applications and requirements for accreditation of Civil Society Organizations, by the Committee on Rules, Privileges and Ordinance and Legal Matters, the Taytay sa Kauswagan, Incorporated (TKSI) has been qualified to be recognized as a People's Organization (POs) in the municipality;

WHEREAS, recognition of the above-cited People's Organization would promote transparency in all government transactions and enhance citizens' organizations' participation and encourage the citizenry to become partners of the local government unit in nation-building as envisioned by the Code;

NOW THEREFORE:


On motion of Hon. Leovy C. Simora, duly seconded by Hon. Nemesio A. Cachite;


