**Resolution No. 13 - 2017**

**RESOLUTION GRANTING OMNIBUS AUTHORITY TO HON. MAYOR MARK P. PALABRICA TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) IN BEHALF OF THE MUNICIPALITY OF BINGAWAN, WITH THE PROVINCIAL GOVERNMENT OF ILOILO, REPRESENTED BY HON. GOVERNOR ARTHUR D. DEFENSOR, SR., FOR FUTURE FINANCIAL ASSISTANCE AND/OR TRANSFER OF FUNDS FROM THE PROVINCIAL GOVERNMENT OF ILOILO.**

**WHEREAS**, the Municipality of Bingawan has requested financial assistance to the Iloilo Provincial Government and has been a recipient of various programs and projects for infrastructure development, socio-cultural programs, purchase of equipment, facilities and/or goods ;

**WHEREAS**, the Commission on Audit Circular No. 2012-001, prescribes the Revised Guidelines and Documentary Requirements for Common Government Transactions;

**WHEREAS**, relative to the mandate of said COA Circular, Hon. Governor Arthur D. Defensor, Sr., enjoined all municipal mayors of the province to secure an omnibus authority from the respective Sanggunian to enter into a Memorandum of Agreement with the Provincial Government;

**WHEREAS**, pursuant to Section 22 © of R.A. 7160, otherwise known as the Local Government Code of 1991, "no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the sanggunian concerned. A legible copy of such contract shall be posted at a conspicuous place in the municipal hall";

**NOW THEREFORE:**

**ON MOTION** of Hon. Perceval T. Girao, duly seconded by Hon. Nemesio A. Cachite;

**RESOLVED, AS IT IS HEREBY RESOLVED**, to grant omnibus authority to Hon. Mayor Mark P. Palabrica to enter into a Memorandum of Agreement (MOA) in behalf of the Municipality of Bingawan, with the Provincial Government of Iloilo, represented by Hon. Governor Arthur D. Defensor, Sr., for future financial assistance and/or transfer of funds from the Provincial Government of Iloilo.


