URGENT RESOLUTION TO TRANSFER FUND IN THE AMOUNT OF FOUR HUNDRED FIFTY ONE THOUSAND NINE HUNDRED FIFTY NINE PESOS AND 50/100 (PHP451,959.50) FROM THE 20% DEVELOPMENT FUND CALENDAR YEAR 2017 TO BINGAWAN KALAHICIDSS ACCOUNT.

WHEREAS, the local government unit of Bingawan is implementing the KALAHICIDSS: NCDDP in the Municipality of Bingawan;
