Resolution No. 17 – 2017

RESOLUTION OF CONDOLENCE TO THE BEREAVED SOTERNO FAMILY AND THE APPRECIATION OF THE LEGACY LEFT BEHIND BY THE LATE ADRIANO CORDERO SOTERNO.

WHEREAS, the late Adriano Cordero Soterno started his public service career when he was called to active duty in the Philippine Army last December 15, 1941 with the rank of Private First Class Inf with Army Serial Number 031248; was inducted to United States of American Forces in the Far East (USAFFE), on December 17, 1941, assigned at "C" Co, 61st Div. Inf USAFFE in Jaro, Iloilo;

WHEREAS, February 13, 1942 his unit was disbanded due to lack of supplies and ammunition which made him to decide to engage in farming to feed his family in Calinog, Iloilo;

WHEREAS, due to his undying love for country, he volunteered to join the Guerilla Movement and on September 9, 1942, he was inducted as a member of the 6thMD Panay Grla. in Calinog, Iloilo; and on September 10, 1942 to May 23, 1945 he was assigned to the "D" Co, 63 Inf Regt. in Mandurriao, Iloilo;

WHEREAS, as a guerilla, he was assigned as a Rifleman and their unit engaged in ambushing Japanese soldiers in Capiz proper last October 7, 1942, and also raided the Japanese Garrison in Calinog and Lambunao last March 21, 1945;

WHEREAS, he was given a Certificate of Recognition as a World War II hero by Governor Arthur Defensor, Sr. last 18th day of March 2015 at Balantang Memorial Cemetery National Shrine, Bgy. Quintin Salas Jaro, Iloilo City;

WHEREAS, due to his untimely demise the local government of Bingawan, Iloilo, shares that grief with the Soterno Family, and appreciates the legacy left behind by the late Adriano Cordero Soterno; and as a World War II hero, he will always be remembered by the Bingawanons of today and the generations to come;
