RESOLUTION AUTHORIZING HON. MARK P. PALABRICA, MUNICIPAL MAYOR TO DONATE PORTION OF LOT NO. 7264-A-3 FOR AND IN BEHALF OF THE MUNICIPALITY OF BINGAWAN, ILOILO TO THE DEPARTMENT OF INTERIOR AND LOCAL GOVERNMENT REGIONAL OFFICE 6 TO BE USED FOR THE ESTABLISHMENT OF THE LOCAL GOVERNMENT OPERATIONS CENTER (LGOC) AT BARANGAY, POBLACION, BINGAWAN, ILOILO.”

WHEREAS, the Municipality of Bingawan has written the Department of Interior and Local Government of its express intention in availing the fund for the Local Government Operation’s Center last April 4, 2016;

WHEREAS, the LGU has an available 500 sq. m. lot within the Municipal Hall compound where the future building can be located;

WHEREAS, Bingawan has not rebuilt much of the public buildings that were destroyed by Typhoon Yolanda such as the Offices of the Local, National and Provincial Agencies stationed in the Municipality where housed;

WHEREAS, the LGOC will fill the building deficit of the LGU and will finally give the said Offices a permanent workplace to better serve the public;

WHEREAS, the Municipality of Bingawan, out of pure generosity and concern for the cause of public service, as a donor give, transfer and convey the said lot to the Department of Interior and Local Government.

RESOLVED, AS IT IS HEREBY RESOLVED, to authorize Hon. Mark P. Palabrica, Municipal Mayor to donate portion of Lot No. 7264-A-3 for and in behalf of the Municipality of Bingawan, Iloilo to the Department of Interior and Local Government Regional Office 6 to be used for the establishment of the Local Government Operations Center (LGOC) at Barangay, Poblacion, Bingawan, Iloilo.
