PALABRICA, MUNICIPAL MAYOR, MUNICIPALITY OF BINGAWAN, ILOILO TO ENTER AND SIGN FOR AND IN BEHALF OF THE MUNICIPALITY OF BINGAWAN, ILOILO A MEMORANDUM OF AGREEMENT WITH THE BIZBOX, INC. WITH PRINCIPAL ADDRESS AT UNIT 1103 11th FLOOR, ANTEL 2000 CORPORATE CENTER, 121 VALERO STREET, SALCEDO VILLAGE, MAKATI CITY AND HEREIN REPRESENTED BY ITS AUTHORIZED REPRESENTATIVE, MR. BOBBY L. LUA AND MS. FRAULINE P. ROSARIO FOR THE BIZBOX ELECTRONIC CLAIMS PORTAL.

WHEREAS, BIZBOX has developed a cloud based system called, BIZBOX Electronic Claims Portal which enables hospitals to process their Philhealth claims online;

WHEREAS, BIZBOX has been accredited by Philhealth for the processing of electronic claims on a non-exclusive basis;

WHEREAS, the client uses **BIZBOX E-CLAIMS** for its operations;

WHEREAS, the system will benefit the Philhealth clients in the Municipality by having an easy access to the portal when processing their Philhealth claims;

WHEREAS, Section 22 (c) of RA 7160 provides that "no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the Sanggunian concerned";
