**WHEREAS**, the Local Government of Bingawan is a recipient of the KALAHİ-CIDSS National Community Driven Development Project under the Department of Social Welfare and Development;

**WHEREAS**, in order to effectively implement the above-mentioned projects the Municipality hired the services of Community Empowerment Facilitators, Assistant Municipal Financial Analyst, Municipal Encoder and Operation & Maintenance (O&M) Focal Person;

**WHEREAS**, the Municipal Coordinating Team is in need of a new Community Empowerment Facilitator to replace Ms. Mara Joy Castillanes who was hired as Admin Aide III of the Municipality of Bingawan;

**WHEREAS**, Mrs. Rejean P. dela Cruz signified her intention to apply as KALAHİ Community Empowerment Facilitator and that she possesses the education, experience and skills required to perform the job;

**WHEREAS**, pursuant to Sec. 22 of R.A. 7160 otherwise known as the Local Government Code of 1991 provides that "no contract maybe entered into by the Local Chief Executive without prior authorization by the Sangguniang Bayan concerned. A legible copy of such contract shall be posted in a conspicuous place in the municipal hall."


