WHEREAS, the Local Government of Bingawan is a recipient of the KALAHY-CIDSS National Community Driven Development Project under the Department of Social Welfare and Development;

WHEREAS, in order to effectively implement the above-mentioned projects the Municipality hired the services of Community Empowerment Facilitators, Assistant Municipal Financial Analyst, Municipal Encoder and Operation & Maintenance (O&M) Focal Person;

WHEREAS, the Municipal Coordinating Team is in need of a new Community Empowerment Facilitator to replace Mr. Von Catorce who refused to sign the renewal of his contract due to his application as Administration Aide III of the Municipality of Bingawan;

WHEREAS, Mr. Ross Mark Compas signified his intention to apply as KALAHY Community Empowerment Facilitator and that he possesses the education, experience and skills required to perform the job;

WHEREAS, pursuant to Sec. 22 of R.A. 7160 otherwise known as the Local Government Code of 1991 provides that "no contract maybe entered into by the Local Chief Executive without prior authorization by the Sangguniang Bayan concerned. A legible copy of such contract shall be posted in a conspicuous place in the municipal hall."

NOW THEREFORE:




