**Resolution No. 36 – 2017**

**URGENT RESOLUTION AUTHORIZING HON. MARK P. PALABRICA, MUNICIPAL MAYOR, MUNICIPALITY OF BINGAWAN, ILOILO TO ENTER AND SIGN FOR AND IN BEHALF OF THE MUNICIPALITY OF BINGAWAN, ILOILO A MEMORANDUM OF AGREEMENT WITH THE BALAY PAGLAUM, A CRISIS CENTER OWNED BY THE MUNICIPALITY OF MINA REPRESENTED BY ITS MUNICIPAL MAYOR, HON. REY P. GRABATO WITH OFFICE ADDRESS AT MINA TOWN HALL, PATARATA ST., MINA, ILOILO.**

**WHEREAS**, the Balay Paglaum was established to resolve cases on Children in Conflict with the Law(CICL) and other behavioral pattern problems to serve, assist and protect individuals and families, women, and children in crisis situation in ways that strengthen their coping capacity and encourage personal responsibility to prevent them from further exposure to calamity, exploitation, abuse, neglect and displacement, and to enable youthful offenders restore their normal functioning towards family reunification and community reintegration;

**WHEREAS**, the sane also serves as temporary shelter and restorative services to Children in Conflict with the Law (CICL) for placement setting, referral and for other rehabilitative related services;

**WHEREAS**, the Balay Paglaum is already operational and ready to accept clients coming from other municipalities/entities as “catchment” or temporary shelter of not more than three (3) weeks as specified in the Municipal Ordinance No. 2012-212;

**WHEREAS**, in line thereto, the municipality needs to execute a Memorandum of Agreement (MOA) with the referring party/s for specific guidelines on their respective responsibilities as regards to the acceptance of clients referred to the Balay Paglaum;

**WHEREAS**, Section 22 (c) of RA 7160 provides that "no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the Sanggunian concerned".

**NOW THEREFORE:**


