URGENT RESOLUTION AUTHORIZING HON. MARK P. PALABRICA, MUNICIPAL MAYOR, MUNICIPALITY OF BINGAWAN, ILOILO TO ENTER AND SIGN FOR AND IN BEHALF OF THE MUNICIPALITY OF BINGAWAN, ILOILO A MEMORANDUM OF AGREEMENT WITH CAMELEON ASSOCIATION, INC., WITH BUSINESS ADDRESS AT BARANGAY SABLOGON, PASSI CITY, PROVINCE OF ILOILO, HEREIN REPRESENTED BY MS. SABINE CLAUDIO, EXECUTIVE DIRECTOR, FOR PSYCHO/SOCIAL COUNSELING AFTER THE OCCURRENCE OF DISASTER.

WHEREAS, the Local Government Unit is mandated by law to extend assistance to victims of disasters;

WHEREAS, the LGU has a five percent (5%) Municipal Disasters Risk Reduction Management Fund, of the amount appropriated for MDRRMF, thirty percent (30%) shall be allocated as Quick Response Fund (QRF) for the relief and recovery programs in order that situation and living conditions of people in communities or areas stricken by disasters, calamities, epidemics, complex emergencies, may be normalized as quickly as possible;

WHEREAS, the **CAMELEON ASSOCIATION, INC.**, is a non-government organization accredited by the Department of Social Welfare and Development (DSWD) as an association that encompass the program of Personal Reconstruction/Rehabilitation and offer Social, Moral and Mental Recovery to the member of the community affected with tragedy like calamity and disasters;

WHEREAS, the LGU cannot utilize their Quick Response Fund of thirty percent (30%) of the five percent (5%) MDRRM Fund before the occurrence of any disaster;

WHEREAS, by reason of limitations provided in the use of the said fund, the LGU recognizes the need to make arrangements with the association for the immediate personal reconstruction/rehabilitation by offering social, moral and mental recovery thru Focus Group Discussions and/or Personal Counseling after disaster occurrence;

WHEREAS, Section 22 (c) of RA 7160 provides that “no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the Sanggunian concerned”;

NOW THEREFORE:

ON MOTION of Hon. Joy L. Quimba; duly seconded by Hon. Ted Peter P. Plagata;

RESOLVED AS IT IS HEREBY RESOLVED, to authorize Hon. Mark P. Palabrica, Municipal Mayor, Municipality of Bingawan, Iloilo to enter and sign for and in behalf of the Municipality of Bingawan, Iloilo a Memorandum of Agreement with Cameleon Association, Inc., with business address at Barangay Sablogon, Passi City, Province of Iloilo, herein represented by Ms. Sabine Claudio, Executive Director, for Psycho/Social Counseling after the occurrence of disaster.


