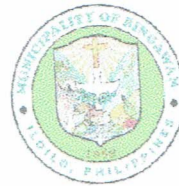

**Resolution No. 47 - 2017**

**RESOLUTION OF CONDOLENCE TO THE BEREAVED CELESTE FAMILY AND TO APPRECIATE THE LEGACY LEFT BEHIND BY THE LATE LETICIA PACIFICAR CELESTE.**

**WHEREAS**, the late Leticia Pacificar Celeste started her Public Service Career last May 30, 1973 as a Casual Employee of Bureau of Agricultural Extension (BAE) Region 6 until December 16, 1979; from October 14, 1981 until October 13, 1982 as Temporary Farm Management Technician I at the Bureau of Agricultural Extension Region 6; on a Permanent Status as Farm Management Technician from October 14, 1982 until December 31, 1984; held the same position and was assigned at the MAF Region 6 from January 1, 1985 to February 28, 1987; from March 1, 1987; she was promoted as Agricultural Technologist at DA Region 6 last July 1, 1989 until December 30, 1992; assigned at the Municipal Agriculture Office when it was devolved to the Local Government of Bingawan, in December 31, 1992 until October 16, 1997; and held the position as Municipal Agriculturist this Municipality since October 17, 1997 until December 31, 2005;

**WHEREAS**, her 30 years or so of perseverance in the government service was due to her sterling qualities of honesty, sincerity and dedication, roaming in all barangays to see to it that local farmers' problems are properly addressed, giving them truthful and fruitful advices;

**WHEREAS**, due to her death the Local Government of Bingawan, shares that grief with the Celeste Clan and as a Model of her people, who are mostly farmers, the late Leticia P. Celeste will be forever remembered by the present and future generations of Bingawanons;

**ON MOTION** of Hon. Leovy C. Simora, Floor Leader, duly seconded by Hon. Nemesio A. Cachite;


