MUNICIPAL ORDINANCE NO. 219
(Series of 2016)

AN URGENT ORDINANCE TEMPORARILY CLOSING A PORTION OF PLAGA ST., FROM BONIFACIO CASTRONUEVO'S RESIDENCE TO PUROK 1 CROSSING, THIS MUNICIPALITY.

WHEREAS, pursuant to the provisions of Section 21, of R.A. 7160, otherwise known as the Local Government Code of 1991, "a local government, may pursuant to an ordinance, temporarily close any local road within its jurisdiction;

NOW, THEREFORE:

Be it ordained by the Sangguniang Bayan of Bingawan, Iloilo, in a regular session assembled that:

Section 1. A portion of Plaga St., from Bonifacio' Castronuevo's Residence to Purok 1 Crossing shall be temporarily closed on May 25, 2016;

Section 2. Said temporary closure shall be automatically lifted after the wake of the late Mrs. Mercia Castronuevo Canonigo;

Section 3. Brgy. Tanod of Poblacion shall maintain peace and order in the area cited in close coordination with the local PNP;


Section 4. This ordinance shall take effect immediately.




