MUNICIPAL ORDINANCE NO. 225
(Series of 2016)

AN URGENT ORDINANCE GRANTING EXEMPTION FROM LOCAL FEES FOR THE ISSUANCE OF BIRTH CERTIFICATES IN SECPA COPY THROUGH BREQS TO ALL ATHLETES REPRESENTING THE MUNICIPALITY OF BINGAWAN, ILOILO IN ALL DEPED- SANCTIONED SCHOOL SPORTS MEET.

WHEREAS, Section 192 of R.A. 7160 provides that local government units may, through an ordinance, grant tax exemptions, incentives or reliefs under such terms and conditions as they may deem necessary;

WHEREAS, the Department of Education in Bingawan, Iloilo and the parents of the players are requesting the municipality to grant them the certified copies of birth certificates of athletes duly issued by the Local Civil Registrar free of charge;

NOW, THEREFORE;

ON MOTION of Hon. Matt P. Palabrica, Ph.D., duly seconded by Hon. Perceval T. Girao, Hon. Eduardo A. Dalipe, Hon. Nemesio A. Cachite and Hon. Jose c. Rabago, Jr.;

BE IT ORDAINED, by the Sangguniang Bayan of the Municipality of Bingawan, Province of Iloilo, in a regular session assembled, that:

Section 1. Title. This urgent ordinance shall be known as "An urgent ordinance granting exemption from local fees for the issuance of birth certificates in SECPA copy through BREQS to all athletes representing the Municipality of Bingawan, Iloilo in all DEPED- sanctioned school sports meet".

Section 2. Tax Exemption.- All athletes representing the Municipality of Bingawan in DepEd-sanctioned school sports meet such as the Iloilo Third Congressional District Sports Association (CDSA) Meet, Iloilo Sports Council (Integrated) Meet, Western Visayas Regional Athletic Association (WVRAA) Meet, and the Palarong Pambansa shall be exempted from paying local fees for the issuance of Birth Certificates in SECPA copy through BREQS at the office of the Municipal Civil Registrar.


Section 3. Administrative Provision.- The Municipal Civil Registrar is hereby authorized to issue guidelines for the implementation of this ordinance subject to the approval of the Municipal Mayor which shall form part of the Implementing Rules of this ordinance.

Section 4. Effectivity. This Ordinance shall take effect upon its approval.




