**MUNICIPAL ORDINANCE NO. 226
(Series of 2016)**

AN ORDINANCE TEMPORARILY CLOSING A PORTION OF CATALUNA STREET, FRONTING GALLAZA RESIDENCE THIS MUNICIPALITY.

WHEREAS, pursuant to the provisions of Section 21, of R.A. 7160, otherwise known as the Local Government Code of 1991, "a local government, may pursuant to an ordinance, temporarily close any local road as described and provided therein";

NOW, THEREFORE:

On motion of Hon. Joy L. Quimba, duly seconded by Hon. Nemesio A. Cachite;

Be it ordained by the Sangguniang Bayan of Bingawan, Iloilo, in a regular session assembled that:

Section 1. Title. An Ordinance Temporarily Closing a Portion of Castaluña Street, this Municipality, fronting Gallaza residence on October 24 – November 5, 2016.

Section 2. Purpose. The temporary closure is intended to accommodate friends, guests and relatives for the wake of Modesta Castroverde Mejares.

Section 3. Duration. Such temporary closure shall be automatically lifted on the day after the wake.

Section 4. Members of barangay tanod and local PNP shall maintain peace and order during said occasion.

Section 5. Effectivity. This ordinance shall take effect immediately.


