**MUNICIPAL ORDINANCE NO. 227  
(Series of 2016)**

**AN ORDINANCE TEMPORARILY CLOSING A PORTION OF PAGARA ST., BESIDE JONELITO SALADAR'S RESIDENCE, THIS MUNICIPALITY.**

**WHEREAS**, pursuant to the provisions of Section 21, of R.A. 7160, otherwise known as the Local Government Code of 1991, "a local government, may pursuant to an ordinance, temporarily close any local road as described and provided therein";

**WHEREAS**, Ms. Rosie Plaga requested before this office a temporary closure of Cataluña Street, Poblacion, Bingawan, Iloilo dated November 17, 2016 fronting Saladar's Residence. The said street fronting the Saladar's Residence is a national road and there is an on-going construction of Bingawan Rural Health Station; thus the said request if granted may obstruct traffic and may result inconvenience to the public;

**WHEREAS**, in consideration of the above-stated reasons, the temporary closure should be at Pagara Street beside Saladar's Residence;

**NOW, THEREFORE:**

**ON MOTION** of Hon. Jofe C. Celeste, duly seconded by Hon. Lorens M. Belloga;

Be it ordained by the Sangguniang Bayan of Bingawan, Iloilo, in a regular session assembled that:

Section 1. Title. An Ordinance Temporarily Closing a Portion of Pagara St, this Municipality, beside Jonelito Saladar's Residence on November 18 - December 3, 2016.

Section 2. Purpose. The temporary closure is intended to accommodate friends, guests and relatives for the wake of Angelita Celebria Saladar.

Section 3. Duration. Such temporary closure shall be automatically lifted on the day after the wake.


Section 4. Members of barangay tanod and local PNP shall maintain peace and order during said occasion.




