PALABRICA, MUNICIPAL MAYOR, MUNICIPALITY OF BINGAWAN, ILOILO TO ENTER AND SIGN FOR AND IN BEHALF OF THE MUNICIPALITY OF BINGAWAN, ILOILO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD)- FIELD OFFICE VI WITH OFFICE ADDRESS AT M.H. DEL PILAR STREET, MOLO, ILOILO CITY AND HEREIN REPRESENTED BY ITS REGIONAL DIRECTOR, REBECCA P. GEAMALA FOR THE SOCIAL PENSION FOR INDIGENT SENIOR CITIZENS.

WHEREAS, the Department of Social Welfare and Development, is mandated to provide social welfare and development programs particularly through technical assistance and resource augmentation;

WHEREAS, the DSWD, is continuously implementing programs/projects and providing augmentation assistance to local government unit (LGU), non-government organization, and other partner agencies, to help alleviate poverty and ensure welfare of the disadvantage and vulnerable groups;

WHEREAS, the Social Pension for Indigent Senior Citizens is an additional government assistance to augment the daily subsistence and other medical needs of indigent senior citizens;

WHEREAS, Section 22 (c) of RA 7160 provides that “no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the Sanggunian concerned”;

NOW THEREFORE:




