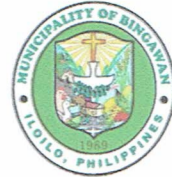

**AN URGENT RESOLUTION PROVIDING A LOCAL COUNTERPART IN THE FORM OF SAND, GRAVEL AND LABORERS AMOUNTING TO FOUR HUNDRED FIFTY THOUSAND PESOS (PHP450,000.00) FOR THE IMPLEMENTATION OF PROJECTS UNDER THE PAMANA PROGRAM: OPENING OF BARANGAYS INAMYUNGAN-QUINAR-UPAN FARM-TO-MARKET ROAD (CONSTRUCTION/SPOT CONCRETING OF ROADS).**

**WHEREAS**, the Municipality Bingawan is one of the recipients of the Farm-to-Market Roads located at Brgys. Inamyungan-Quinar-upan, under PAMANA, a national government flagship program to respond and strengthen peacebuilding, reconstruction and development in conflict-affected areas (CAAs) in selected priority regions in the country;

**WHEREAS**, the Department of Agriculture requires the municipality to come up with the local counterpart in the form of sand and gravel and laborers in the total amount of Four Hundred Fifty Thousand Pesos (Php450,000.00) which has been provided by the LGU in its 20% Development Fund CY 2016;


**NOW, THEREFORE:**

#### VI. EFFECTIVITY


The provisions of this resolution shall take immediately.


