URGENT RESOLUTION AUTHORIZING HON. MARK P. PALABRICA, MUNICIPAL MAYOR, MUNICIPALITY OF BINGAWAN, ILOILO TO ENTER AND SIGN FOR AND IN BEHALF OF THE MUNICIPALITY OF BINGAWAN, ILOILO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD)- FIELD OFFICE VI . WITH OFFICE ADDRESS AT M.H. DEL PILAR STREET, MOLO, ILOILO CITY AND HEREIN REPRESENTED BY ITS REGIONAL DIRECTOR, REBECCA P. GEAMALA FOR THE SUPPLEMENTARY FEEDING PROGRAM.

WHEREAS, Department of Social Welfare and Development (DSWD) is the government agency that is primarily responsible in delivering coordinated social protection services aimed at eradicating poverty;

WHEREAS, DSWD envisions a society where the poor, vulnerable and disadvantaged individuals, families, and communities are empowered for an improved quality of life;

WHEREAS, DSWD takes protection of the poor and marginalized as its main mission which it seeks to achieve through the implementation of various projects, programs, and activities collectively referred to as "Social Protection";

WHEREAS, the Local Government Unit is mandated by law to address the needs of its constituents, empower its people and allow them the widest possible participation in government affairs;

WHEREAS, there is a need to authorize the Local Chief Executive to enter into a Memorandum of Agreement with DSWD for strengthened partnership and for the more effective implementation of programs, projects, and activities aimed at eradicating poverty and people empowerment.

WHEREAS, Protein Energy Malnutrition (PEM) affects the most vulnerable sector of the population, the pre-school children. Aside from PEM, young children also suffer from deficiencies of Iron, Iodine and Vitamin A. Thus, malnutrition is not only a consequence but also a cause for poverty and block to development.

WHEREAS, Section 22 (c) of RA 7160 provides that "no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the Sanggunian concerned".

NOW THEREFORE:

RESOLVED AS IT IS HEREBY RESOLVED, to authorize Hon. Mark P.
