URGENT RESOLUTION AUTHORIZING HON. MATT P. PALABRICA, Ph.D., MUNICIPAL MAYOR, MUNICIPALITY OF BINGAWAN, ILOILO TO ENTER AND SIGN FOR AND IN BEHALF OF THE MUNICIPALITY OF BINGAWAN, ILOILO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT REPRESENTED BY ITS OIC-REGIONAL DIRECTOR, REBECCA P. GEAMALA FOR THE IMPLEMENTATION OF THE SUPPLEMENTARY PROGRAM.

WHEREAS, Department of Social Welfare and Development (DSWD) is the government agency that is primarily responsible in delivering coordinated social protection services aimed at eradicating poverty;

WHEREAS, DSWD envisions a society where the poor, vulnerable and disadvantaged individuals, families, and communities are empowered for an improved quality of life;

WHEREAS, the Local Government Unit is mandated by law to address the needs of its constituents, empower its people and allow them the widest possible participation in government affairs;

WHEREAS, there is a need to authorize the Local Chief Executive to enter into a Memorandum of Agreement with DSWD for strengthened partnership and for the more effective implementation of programs, projects, and activities aimed at eradicating poverty and people empowerment;

WHEREAS, pursuant to Section 22 (c) of R.A. 7160, "no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the Sanggunian concerned. A legible copy of such contract shall be posted at a conspicuous place in the municipal hall";

NOW, THEREFORE:




