URGENT RESOLUTION AUTHORIZING HON. MARK P. PALABRICA, MUNICIPAL MAYOR, MUNICIPALITY OF BINGAWAN, ILOILO TO ENTER AND SIGN FOR AND IN BEHALF OF THE MUNICIPALITY OF BINGAWAN, ILOILO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF LABOR AND EMPLOYMENT REGIONAL OFFICE VI WITH PRINCIPAL OFFICE ADDRESS AT SWAN ROSE BUILDING, COMMISSION CIVIL STREET, JARO, ILOILO CITY, REPRESENTED HEREIN BY ITS REGIONAL DIRECTOR, ATTY. JOHNSON G. CAÑETE, CESO III, AND HEREIN REFERRED AS TO “DOLE” RO VI” FOR THE IMPLEMENTATION OF THE TULONG PANGHANAPBUHAY SA ATING DISPLACED/DISADVANTAGED (TUPAD) WORKERS PROGRAM.

WHEREAS, it is the National Government’s policy to implement poverty alleviation project in all regions;

WHEREAS, the Department of Labor and Employment (DOLE) is mandated to promote gainful employment opportunities, develop human resources, project workers and promote their welfare, and maintain industrial peace;

WHEREAS, the DOLE provides assistance to help displaced or “to be” displaced workers in coping with the closure or slowing down of operations of companies as a result of economic disruptions and/or the occurrence of natural disasters, calamities, or armed conflicts that affect their economic base and to augment the meager income of the underemployed and seasonal workers under its **TULONG PANGHANAPBUHAY SA ATING DISPLACED/DISADVANTAGED (TUPAD) WORKERS PROGRAM**, pursuant to the provisions of DO No. 173 series of 2017;

WHEREAS, the DOLE-RO No. VI has been given the responsibility to implement the TUPAD Program to enable the displaced workers, unemployed and seasonal workers to engage in short-term community works to provide them with temporary wage employment for a period of Fifteen (15) days;

WHEREAS, this partnership is vital to ensure the successful implementation of the said projects and achieve their desired social outcomes;

WHEREAS, Section 22 (c) of RA 7160 provides that “no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the Sanggunian concerned”;

NOW THEREFORE:


On motion of Hon. Leovy C. Simora, Floor Leader, duly seconded by Hon. Nemesio A. Cachite and Hon. Ted Peter P. Plagata;

RESOLVED AS IT IS HEREBY RESOLVED, to authorize Hon. Mark P. Palabrica, Municipal Mayor, Municipality of Bingawan, Iloilo to enter and sign for and in behalf of the Municipality of Bingawan, Iloilo a Memorandum of Agreement with Department of Labor and Employment Regional Office VI with principal office address at Swan Rose Building, Commission Civil Street, Jaro, Iloilo City, represented herein by its Regional Director, Atty. Johnson G. Cañete, CESO III, and herein referred as to “DOLE” RO VI” for the implementation of the Tulong Panghanapbuhay sa ating Displaced/Disadvantaged (TUPAD) Workers Program.
