URGENT RESOLUTION FOR THE TRANSFER OF FUND IN THE AMOUNT OF SEVENTY THOUSAND FIVE HUNDRED PESOS (PHP70,500.00) CHARGEABLE AGAINST THE 20% DEVELOPMENT FUND CALENDAR YEAR 2015 TO BINGAWAN KALAHICIDSS ACCOUNT.


