URGENT RESOLUTION AUTHORIZING HON. MARK P. PALABRICA, MUNICIPAL MAYOR, MUNICIPALITY OF BINGAWAN, ILOILO TO ENTER AND SIGN FOR AND IN BEHALF OF THE MUNICIPALITY OF BINGAWAN, ILOILO A MEMORANDUM OF AGREEMENT WITH THE CENTRAL PHILIPPINE UNIVERSITY, REPRESENTED BY ITS PRESIDENT, TEODORO C. ROBLES, Ph.D., TO AVAIL OF ITS OUTREACH PROGRAMS AND SERVICES.

WHEREAS, the Central Philippine University has its vision as follows “A University committed to Exemplary Christian Education for Life (EXCEL) and responsive to the needs of the total person and the world”;

WHEREAS, CPU established the Community Engagement and Service-Learning Center as a development arm to implement social development programs that help improve the life of our people with the following objectives: 1.) Faculty, staff and student who are actively involved in the outreach programs and community services, 2.) Each college/unit will have an integrated functional outreach program and with one additional partner community every two years, 3.) non-government organizations and people’s organization, 4.) Regular monitoring and evaluation of programs and services implemented in existing and new partner communities, 5.) partner communities are serving other communities;

WHEREAS, the University has been engaged in various programs and services to reach those goals;

WHEREAS, Bingawan, through its Hon. Mark P. Palabrica has indicated its willingness to avail of the outreach programs and services of the University and its different colleges in a long term basis through partnership with a commitment to provide necessary support and cooperation for the good of its constituencies;

WHEREAS, Section 22 (c) of RA 7160 provides that “no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the Sanggunian concerned”.

NOW THEREFORE:


On motion of Hon. Leovy C. Simora, Floor Leader, duly seconded by Hon. Nemesio A. Cachite;
