RESOLUTION SUPPORTING RESOLUTION NO. 2017-519 OF THE SANGGUNIANG PANLUNGSOD OF ILOILO CITY, A RESOLUTION URGING THE NEW SECRETARY OF THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) TO ADOPT AND IMPLEMENT MEMORANDUM CIRCULAR NO. 09, SERIES OF 2016 ENTITLED: SUPPLEMENTAL GUIDELINES ON THE IMPLEMENTATION OF PROTECTIVE SERVICES PROGRAM (PSP).

WHEREAS, Resolution No. 2017-519 of the Sangguniang Panlungsod of Iloilo City was formulated to encourage the new Department of Social Welfare and Development (DSWD) Secretary to adopt and implement Memorandum Circular No. 09, Series of 2016 and was supported by Sangguniang Panlalawigan Resolution No. 2017-819 dated December 3, 2017;

WHEREAS, Memorandum Circular No. 09 Series of 2016 entitled: Supplemental Guidelines on the Implementation of Protective Services Program (PSP) was issued and signed on August 01, 2016 by former DSWD Secretary Judy Taguiwalo;

WHEREAS, Memorandum Circular No. 09, Series of 2016 was in accordance with Supreme Court Decision in the case of Belgica, et al. vs. Executive Secretary Ochoa et al. (G.R 208566, November 19, 2013), Commission on Audit (COA) Memorandum dated March 01, 2016, General Appropriation Act (GAA) of 2015 and GAA of 2016 and DSWD Memorandum Circular (MC) No. 04, S. 2015;

WHEREAS, Memorandum Circular No. 09, Series of 2016 provides that referral letters from public officials are not integral to the implementation of the agency's protective services program, and not binding on its personnel;

WHEREAS, Memorandum Circular No. 09, Series of 2016 states that while the letters could be considered, the DSWD retained the sole authority to determine the beneficiaries pursuant to existing guidelines;

WHEREAS, Memorandum Circular No. 09, Series of 2016 was issued by former DSWD Secretary Judy Taguiwalo to properly address the pro-poor program of President Rodrigo Duterte and is justifiable to be adopted and continued by the new DSWD Secretary;

WHEREAS, the Sangguniang Bayan in the Municipality of Bingawan, Iloilo is supporting Resolution No. 2017-519 of the Sangguniang Panlungsod of Iloilo City, "A Resolution Urging the new Secretary of the Department of Social Welfare and Development (DSWD) to adopt and Implement Memorandum Circular No. 09, Series of 2016 Entitled: Supplemental Guidelines on the Implementation of Protective Services Program (PSP)".
