URGENT RESOLUTION AUTHORIZING HON. MATT P. PALABRICA, Ph.D., MUNICIPAL MAYOR, TO ACCEPT FOR AND IN BEHALF OF THE MUNICIPALITY OF BINGAWAN, ILOILO THE DEED OF ADJUDICATION WITH A DEED OF DONATION FROM JOEY T. HORTELANO, JOLIL HORTELANO YAP, WESLEY T. HORTELANO AND LILIA T. HORTELANO, THE COMPULSORY HEIRS OF THE LATE JOEL HORTELANO FOR A PORTION OF PARCEL OF LAND COVERED BY TRANSFER CERTIFICATE OF TITLE (TCT) NO. T-100479.

WHEREAS, the Municipality of Bingawan is a recipient of a socialized housing from the Filipino-Chinese Benevolent Mission (Philippines), a non-government organization;

WHEREAS, the beneficiaries of the socialized housing project in the municipality are families with no permanent houses and lots, displaced by calamities and families that live in danger zone areas;

WHEREAS, the heirs of the late Joel Hortelano are willing to donate a portion of parcel of land with an area of forty thousand (40,000) square meters situated at Barangay Malitbog Ilaya, Bingawan, Iloilo;

WHEREAS, this authorization was made for the titling of the lot under the name of the Municipality of Bingawan, Iloilo;

WHEREAS, Section 22 (c) of the Local Government Code of 1991 provides that "no contract maybe entered into by the local chief executive in behalf of the Local Government Unit without prior authorization by the Sangguniang concerned. A legible copy of such contract shall be posted at the conspicuous places in the municipal hall";

NOW, THEREFORE:

ON MOTION of Hon. Ross Mark R. Compas, duly seconded by Hon. Nemesio A. Cachite and Hon. Jose C. Rabago, Jr.;

BE IT RESOLVED, as it is hereby resolved, to authorize Hon. Matt P. Palabrica, Ph.D., Municipal Mayor, to accept for and in behalf of the Municipality of Bingawan, Iloilo the Deed of Adjudication with a Deed of Donation from Joey T. Hortelano, Jolil Hortelano Yap, Wesley T. Hortelano and Lilia T. Hortelano, the compulsory heirs of the late Joel Hortelano for a portion of parcel of land covered by Transfer Certificate of Title (TCT) no. T-100479.
