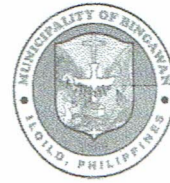

NOW, THEREFORE:




