URGENT RESOLUTION AUTHORIZING HON. MARK P. PALABRICA, MUNICIPAL MAYOR, MUNICIPALITY OF BINGAWAN, ILOILO TO ENTER AND SIGN FOR AND IN BEHALF OF THE MUNICIPALITY OF BINGAWAN, ILOILO A MEMORANDUM OF AGREEMENT WITH THE LAMBUNAO GARMENTS, A GARMENT FACTORY UNDER THE ECONOMIC ENTERPRISE OFFICE OF THE MUNICIPALITY OF LAMBUNAO, REPRESENTED HEREIN BY ITS OFFICER-IN-CHARGE, MS. SOFIA G. HALAGO FOR THE CUSTOM MADE POLO SHIRTS OF THE MUNICIPAL OFFICIALS AND EMPLOYEES.

WHEREAS, the Municipality of Bingawan conducts socio-cultural activities annually as part of its program to preserve and promote local culture;

WHEREAS, the Local Government Unit agreed to provide Polo Shirt Uniform to all LGU Officials and employees to be worn during socio-cultural activities for proper identification;

WHEREAS, the municipality, on its desire to speed up the procurement process chose Lambunao Garments, a government entity to produce the said uniforms;

WHEREAS, Section 22 (c) of RA 7160 provides that "no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the Sanggunian concerned".


