URGENT RESOLUTION AUTHORIZING HON. MARK P. PALABRICA, MUNICIPAL MAYOR TO ENTER INTO AND SIGN THE SPECIFIC IMPLEMENTATION ARRANGEMENTS FOR KALAHI CIDSS NCDDP (CYCLE 3 FROM SAVINGS) OF THE MUNICIPALITY OF BINGAWAN.

WHEREAS, the Local Government of Bingawan is a recipient of Kapit Bisig Laban sa Kahirapan Comprehensive Integrated Delivery of Social Services National Community Driven Development Program (Kalahi CIDSS NCDDP) under the Department of Social Welfare and Development;

WHEREAS, the Municipality has shown good performance in the previous cycle (C1) of KCNCDDP implementation. Hence, the municipality has been given access to avail the grant for the remaining non-prioritized barangay of the cycle 3 implementation;

WHEREAS, in order to implement the above-mentioned program, the Municipality needs to agree on the supplementary agreement to the General Memorandum of Agreement signed between the DSWD, Provincial Government of ILOILO and Municipal Local Government of Bingawan.

WHEREAS, pursuant to Sec. 22 of R.A. 7160 otherwise known as the Local Government Code of 1991 provides that "no contract maybe entered into by the Local Chief Executive without prior authorization by the Sangguniang Bayan concerned. A legible copy of such contract shall be posted in a conspicuous place in the municipal hall."

NOW THEREFORE:


On motion of Hon. Joy L. Quimba, duly seconded by Hon. Nemesio A. Cachite;


