URGENT RESOLUTION REQUESTING FINANCIAL ASSISTANCE FROM HON. ARTHUR R. DEFENSOR, JR., CONGRESSMAN, 3RD DISTRICT OF ILOILO IN THE AMOUNT OF TWO MILLION PESOS (PHP 2,000,000.00) FOR THE IMPROVEMENT AND COMPLETION OF THE MUNICIPAL SLAUGHTERHOUSE IN BARANGAY ALABIDHAN, BINGAWAN, ILOILO.

WHEREAS, the municipality constructed a new slaughterhouse at Barangay Albidhan, Bingawan, Iloilo;

WHEREAS, due to a very limited fund the slaughterhouse for a number of years now remains non-operational due to its unfinished state;

WHEREAS, the present slaughterhouse situated in Barangay Poblacion is surrounded by residential houses, is dilapidated and was heavily damaged by Super Typhoon Yolanda;

WHEREAS, the municipality is requesting assistance from Congressman Arthur R. Defensor, Jr. to complete the new Municipal Slaughterhouse;

NOW, THEREFORE:

ON MOTION of Hon. Ross Mark R. Compas, duly seconded by Hon. Nemesio A. Cachite, Hon. Jose C. Rabago, Jr. and Hon. Perceval C. Girao;

BE IT RESOLVED, as it is hereby resolved, to request financial assistance from Hon. Arthur R. Defensor, Jr., Congressman, 3rd District of Iloilo in the amount of Two Million Pesos (Php2,000,000.00) for the improvement and completion of the municipal slaughterhouse in Barangay Alabidhan, Bingawan, Iloilo.
