RESOLUTION AMENDING RULE VII OF THE INTERNAL RULES OF PROCEDURE OF THE 13TH SANGGUNIANG OF THE MUNICIPALITY OF BINGAWAN.

WHEREAS, the Internal Rules of Procedure of the 13thSangguniang Bayan of the Municipality of Bingawan is silent or does not provide any provision on who will act as Floor Leader in the event of the latter's absence;

WHEREAS, Rule VII of the Internal Rules of Procedure of the 13thSangguniang Bayan of the Municipality of Bingawan, shall be read as follows:

Section 3. The Vice Chairperson of the Committee on Rules shall, concurrently, act as the Deputy Floor Leader. In the absence of the Floor Leader, the Deputy Floor Leader shall act as the Acting Floor Leader.

Section 4. In the event of the inavailability of the Floor Leader and the Deputy Floor Leader, any member of the Committee on Rules, upon prior election from among themselves, shall act as the Acting Floor Leader.

NOW THEREFORE:




