PALABRICA, MUNICIPAL MAYOR, MUNICIPALITY OF BINGAWAN, ILOILO TO ENTER AND SIGN FOR AND IN BEHALF OF THE MUNICIPALITY OF BINGAWAN, ILOILO A MEMORANDUM OF AGREEMENT WITH DEPARTMENT OF AGRICULTURE-REGIONAL FIELD OFFICE VI (DA-RFO VI) REPRESENTED BY REMELYN R. RECOTER, MNSA, CESO III, FOR THE IMPLEMENTATION OF THE "PROVISION OF GRAIN MOISTURE METER" PROGRAM.

WHEREAS, the Department of Agriculture supports and undertakes activities to assist and promote the development of the agriculture and fishery postharvest industries in the countryside;

WHEREAS, the DA-RFO VI is the primary agency of the Department of Agriculture in the Region and has the administrative and technical capability to implement the program;

WHEREAS, the DA-RFO VI has the administrative and technical capability to implement the "Provision of Grain Moisture Meter", hereinto referred to as the "PROGRAM";

WHEREAS, Section 22 (c) of RA 7160 provides that "no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the Sanggunian concerned".
