**Resolution No. 23 - 2016**

**URGENT RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR HONORABLE MATT P. PALABRICA, PH. D., OF THE MUNICIPALITY OF BINGAWAN, PROVINCE OF ILOILO TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT WITH THE "WOW! FIREWORKS DULY REPRESENTED BY ITS SOLE-OWNER RON HAMILTON TAN WITH ITS PRINCIPAL OFFICE ADDRESS AT 28 GALLARES STREET, TAGBILARAN CITY, BOHOL, FOR THE FIREWORKS SHOW ON THE UPCOMING FOUNDATION DAY 2016.**

**WHEREAS**, the WOW! Fireworks is the distributor/ supplier and operator of fireworks for which the Municipality of Bingawan engages itself to buy the said items and secure the services of the former for the upcoming Foundation Day in setting the same subject to the condition heretoforth stipulated;

**WHEREAS**, the total cost of the fireworks is Forty Thousand Pesos Only (P 40,000.00),the Municipality of Bingawan shall be obligated to pay Fifty (50%) of the whole price upon the placement of the order from the "WOW! Fireworks" and the remaining balance of Fifty (50%) percent shall be payable in full upon delivery of the stocks on the scheduled date and at least five (5) hours before the agreed time of the fireworks show;

**WHEREAS**, the fireworks display and/or show shall be held at the Municipality of Bingawan, Iloilo, on June 21, 2016 at 10:00 PM. The "WOW! Fireworks" shall be given ample time to inspect the place where the fireworks show/display will be held and subsequently to change the venue if the area is deemed hazardous to the surrounding properties and the residents living nearby. For safety purposes, the "WOW! Fireworks" reserves the right to cancel the fireworks show on the eleventh hour if the crowd control becomes so erratic and unmanageable that the cancellation shall be deemed necessary if only to prevent any untoward accidents and/or injuries to the spectator;

**WHEREAS**, the Municipality of Bingawan shall provide the Local Government/Mayor's Permit. They shall likewise provide security to cordon off the shooting area from curious on-lookers to avoid injury and damage to property. In the interest of promoting the safety of the area, they shall provide at least one (1) fire truck on stand-by basis during fireworks shooting time. The Municipality of Bingawan shall also assume payment of the PNP Fireworks Shooting Permit, if the same is necessary and required by the authorities;

**WHEREAS**, cancellation of the show or non-delivery of all or any part of the merchandise caused by force majeure such as prohibition, revocation of shooting or transportation permit, act of God, war blockade, revolution, insurrection, mobilization, strikers, lockouts, civil commotion, riots, plague or other epidemics, destruction of goods by fire or flood or inclement weather or any other causes beyond the control of the "WOW! Fireworks" shall charge the Municipality of Bingawan thirty (30%) percent of the total cost of the show, representing set-up and miscellaneous costs. The remaining balance of the payment shall be refunded unto the Municipality of Bingawan.

**NOW THEREFORE:**


