RESOLUTION REQUESTING SEC. EMMANUEL F. PIÑOL, SECRETARY, DEPARTMENT OF AGRICULTURE TO ALLOCATE FUNDS IN THE AMOUNT OF THIRTEEN MILLION FIVE HUNDRED THOUSAND PESOS (PHP13,500,000.00) FOR THE CONCRETING OF FARM TO MARKET ROAD, BARANGAY MALITBOG ILAWOD, BINGAWAN, ILOILO.

WHEREAS, a large tract of land of Barangay Malitbog Ilawod is dedicated to the planting of different varieties of vegetables and root crops and the raising of livestock and poultry due to the presence of the MAGMAINAM Cooperative that contribute to the social and economic growth of the community;

WHEREAS, in support to the medium term agricultural development which envisions our country's global competitiveness and people's empowerment, there is a need for the upgrading of the farm to market road to ensure the participation of farmers in attaining maximum agricultural productivity and food security;

WHEREAS, the concreting of FMR in aforesaid barangay will provide efficient and convenient transportation to farmers and commuters to sustain economic growth and uplift the social condition of the residents;

WHEREAS, farm to market roads are among the contributing factors in ensuring food and economic security and sustainability;

WHEREAS, as a fifth class Municipality in the Province of Iloilo, the LGU is being hindered by the budgetary constraints that compelled us to seek financial assistance from different agencies of the national government;
