URGENT RESOLUTION AUTHORIZING HON. MARK P. PALABRICA, MUNICIPAL MAYOR AND MRS. AMALIA Q. PAMOCOL, MUNICIPAL TREASURER TO SIGN AND COUNTERSIGN CHECKS AND WARRANTS FOR EXPENDITURES APPROPRIATED FOR THE OPERATION OF THE LOCAL GOVERNMENT UNIT OF BINGAWAN, ILOILO WHICH MAINTAINED THREE (3) CURRENT ACCOUNTS AND A SAVING ACCOUNT WITH THE DEVELOPMENT BANK OF THE PHILIPPINES LOCATED AT DELA RAMA STREET, ILOILO CITY.

WHEREAS, pursuant to the provisions of the Local Government Code and other pertinent laws and regulations, the Municipal Mayor-being the Local Chief Executive shall have supervision and control over their respective local government unit;

WHEREAS, the Municipality of Bingawan maintained current accounts at the Development Bank of the Philippines that consists of the Local Government Unit Loan Proceeds and Equity of the Department Agrarian Reform-Asian Development Bank-Agrarian Reform Communities Projects II (DAR-ADB-ARCP II) and Department of Agrarian Reform -Asian Development Bank-Agrarian Reform Communities Projects II-Performance Based Grant System (DAR-ADB-ARCP II-PBGS) and savings account of 30% of 5% Calamity Fund of the municipality;

WHEREAS, it is incumbent in the office of the local chief executive to sign checks and warrants, as well as that of the Municipal Treasurer to countersign the same for the payment of the said expenditures appropriated for the operation of the local government unit;

RESOLVED, as it is hereby resolved, to authorize Hon. Mark P. Palabrica, Municipal Mayor and Mrs. Amalia Q. Pamocol, Municipal Treasurer to sign and countersign checks and warrants for expenditures appropriated for the operation of the local government unit of Bingawan, Iloilo which maintained three (3) Current Accounts and a Saving Account with the Development Bank of the Philippines located at Dela Rama Street, Iloilo City.
