WHEREAS, with respect to the signatory in the Contract of Agreement, the Municipal Mayor as Local Chief Executive shall represent the municipality in all contracts as provided under Section 444 (b) (i) (vi) (The Chief Executive: Powers, Duties, Function and Compensation) of the Local Government Code of 1991;

NOW THEREFORE:




