

WHEREAS, Section 80 (b) of RA 7160 otherwise known as the "Local Government Code of 1991 provides that there shall be established in every province, city or municipality a personnel selection board to assist the local chief executive in the judicious and objective selection of personnel for employment as well as for promotion, and in the formulation of such policies as would contribute to employee welfare;


