RESOLUTION REQUESTING HON. ARTHUR D. DEFENSOR, SR., GOVERNOR, PROVINCE OF ILOILO TO ALLOCATE FUNDS IN THE AMOUNT OF ONE MILLION SEVEN HUNDRED THOUSAND PESOS (PHP1,700,000.00) FOR THE CONCRETING OF FARM TO MARKET ROAD, BARANGAY MALITBOG ILAYA, BINGAWAN, ILOILO.

WHEREAS, the residents of Barangay Malitbog Ilaya wanted for the longest time to connect the KALAHI Concrete Road Project to the National Road for easy access of commuters and farm produce to the market;

WHEREAS, the road is badly damaged due to its being made of sand and gravel and continue to deteriorate because of weather conditions;

WHEREAS, the concreting of FMR in aforesaid barangay will provide efficient and convenient transportation to farmers and commuters to sustain economic growth and uplift the social condition of the residents;


