Resolution No. 35 - 2016

URGENT RESOLUTION AUTHORIZING HON. MARK P. PALABRICA, MUNICIPAL MAYOR, MUNICIPALITY OF BINGAWAN, ILOILO TO ENTER AND SIGN FOR AND IN BEHALF OF THE MUNICIPALITY OF BINGAWAN, ILOILO A MEMORANDUM OF AGREEMENT WITH THE NATIONAL FOOD AUTHORITY (NFA) REPRESENTED BY ITS PROVINCIAL MANAGER ERNA Y. ABELLO FOR THE RICE LOAN PROGRAM.

WHEREAS, under the Local Government Code, the local government units are vested with authority to discharge the functions and responsibilities of national agencies and offices devolved to them;

WHEREAS, NFA is the government agency charged with among others ensuring the nation's adequate supply and distribution of grains;

WHEREAS, municipalities in particular have been tasked with providing basic social services including relief assistance in times of calamities;

WHEREAS, the Local Government Units are authorized to set aside an amount equivalent to five (5%) of their Internal Revenue Allotment (IRA) or any amount from their estimated revenue for unforeseen expenditures arising from the occurrence of calamities, provided that such appropriation shall be used only in the area affected by the calamities;

WHEREAS, LGU's are required to set aside an amount equivalent to twenty percent (20%) of their regular income/general fund for contractual debt servicing pursuant to par. B of section 324 of Local government Code;

WHEREAS, in order to provide immediate assistance to our constituents, the lgu has requested NFA to allow us to purchase rice on credit for the relief operation whenever a state of calamity is declared either by the local legislative body or the Office of the President;

NOW THEREFORE:

ON MOTION of Hon. Leovy C. Simora, duly seconded by Hon. Perceval T. Girao and Hon. Nemesio A. Cachite.


