**Resolution No. 35 – 2018**

**URGENT RESOLUTION AUTHORIZING HON. MARK P. PALABRICA, MUNICIPAL MAYOR, MUNICIPALITY OF BINGAWAN, ILOILO TO ENTER AND SIGN FOR AND IN BEHALF OF THE MUNICIPALITY OF BINGAWAN, ILOILO A MEMORANDUM OF AGREEMENT WITH THE ILOILO PROVINCIAL GOVERNMENT REPRESENTED BY HON. ARTHUR D. DEFENSOR, SR, GOVERNOR FOR THE REHABILITATION/CONCRETING OF FARM TO MARKET ROAD AT BARANGAY MALITBOG ILAYA, BINGAWAN, ILOILO.**

**WHEREAS**, the Iloilo Provincial Government has appropriated the amount of One Million Seven Hundred Thousand Pesos (P1,700,000.00) for the rehabilitation/concreting of the Farm to Market Road at Barangay Malitbog Ilaya, Bingawan, Iloilo chargeable against Provincial Roads and Bridges Development Project CY 2018;

**WHEREAS**, the FMR project will provide efficient and convenient transportation to farmers and commuters to sustain economic growth and uplift the social condition of the residents;

**WHEREAS**, Bingawan, through Hon. Mark P. Palabrica and the Sangguniang Bayan wishes to express its sincere gratitude to the Office of the good Governor and Honorable Members of the Sangguniang Panlalawigan for the fund allocation and would like to reiterate its commitment to provide necessary support and cooperation for the implementation and post-implementation of the project;

**WHEREAS**, Section 22 (c) of RA 7160 provides that “no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the Sanggunian concerned”;
