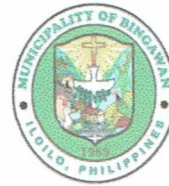

ARTHUR "TOTO" DEFENSOR, JR., CONGRESSMAN, 3rd DISTRICT, PROVINCE OF ILOILO IN THE AMOUNT OF ONE MILLION PESOS (PHP1,000,000.00) AS LOCAL COUNTERPART OF THE MUNICIPALITY OF BINGAWAN FOR THE KALAHI-CIDSS:NCDDP OF THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD).

WHEREAS, the Local Government Unit of Bingawan pursues the objective of alleviating poverty incidence on the local level, which is in pursuance to one of the basic objectives Millennium Development Goals;

WHEREAS, the Municipality agreed to provide the required cash and in-kind counterpart for the implementation of the program as included in the Capability Building Implementation Support (CBIS);

ON MOTION of Hon. Nemesio A. Cachite, duly seconded by Hon. Perceval T. Girao;


