**RESOLUTION INTERPOSING NO OBJECTION TO THE CUTTING OF TREES PLANTED ALONG THE NATIONAL HIGHWAY AFFECTED BY THE IMPROVEMENT/WIDENING OF BAJE-NGINGI-AN-BINGAWAN ROAD, BINGAWAN, ILOILO, K0071+293-K0071+713.**

**WHEREAS**, among the priority of the national government is the road widening project to address traffic congestion nationwide and to reduce or eliminate road accidents along the highways;

**WHEREAS**, national roads within the jurisdiction of this Municipality are planted with trees with various species which mostly are mahogany trees which hamper the road widening project implementation;

**WHEREAS**, this municipality received a letter dated February 14, 2018 from Engr. Sanny Boy Oropel, District Engineer of the Department of Public Works and Highways (DPWH), Iloilo 2<sup>nd</sup> District Engineering Office requesting for a resolution and other supporting documents to support the Tree Cutting Permit at the Department of Environment and Natural Resources (DENR);

**WHEREAS**, in view of the Sangguniang Council of Barangay Poblacion and the Purok Officers of Purok III, Poblacion, which will be affected by this widening, likewise passed their respective resolutions interposing no objections to this effect; hence this resolution;
