RESOLUTION AUTHORIZING HON. MARK P. PALABRICA, MUNICIPAL MAYOR TO ENTER AND SIGN FOR AND IN BEHALF OF THE MUNICIPALITY OF BINGAWAN A MEMORANDUM OF AGREEMENT (MOA) WITH MR. JUNEDEN P. LANDOY, VILLAGE-BASED AI TECHNICIAN (VBAT) FOR THE IMPLEMENTATION OF ARTIFICIAL INSEMINATION PROGRAM OF THE PHILIPPINE CARABAO CENTER.

WHEREAS, to accelerate the development and improvement of the Philippine Carabao for meat and milk production the Municipality of Bingawan and the Philippine Carabao Center collaborates to promote and undertake the various programs related to the development of the carabao industry and help improve the standard living of the rural areas:

WHEREAS, one of the most practical ways of accelerating the improvement of the Philippine Carabao is through crossbreeding using Artificial Insemination by trained village-based AI technicians; and

WHEREAS, the Village-Based AI Technician assigned in the Municipality of Bingawan is Mr. Juneden P. Landoy;

WHEREAS, pursuant to Sec. 22 (c) of R.A. 7160 otherwise known as the Local Government Code of 1991 provides that "no contract maybe entered into by the Local Chief Executive without prior authorization by the Sangguniang Bayan concerned. A legible copy of such contract shall be posted in a conspicuous place in the municipal hall.";

RESOLVED as it is hereby resolved, to authorize Hon. Mark P.
